- Tuition must be current MONTHLY. Delinquent accounts will be excluded from school and will remain out of school until the account is current or arrangements are made with school principal.
- No report cards, records and/or transfers will be issued unless all payments and fees are paid.
- Transfers mid-year will require a payment of the remainder applicable balance of fees.
- The *Action for Children* program is primarily intended to pay childcare expenses. This program is NOT responsible for school tuition & fee cost. Individuals under this program assume all balances not paid by *Action for Children* and must pay the indicated monthly co-pay with no exception. *Co/Payment* (as per DHS paperwork). \_\_\_\_\_ Initial
- \*All recipients of scholarships and financial aid are to abide by the guidelines specified in the *Scholarship & Financial Aid Agreement* & provide 10 hours of service. 5 hours to be done by Jan 11th. \_\_\_\_\_ (initial).
- 8<sup>th</sup> grade students must have all tuition & \$100 graduation fees paid in full by May 15th. Failure to pay results in exclusion from 8th grade events. \_\_\_\_\_ (initial).
- Pre-k & Kinder students must have all tuition & \$25.00 graduation fee paid in full by May 15. Failure to pay results in exclusion from Pre-k, K events. \_\_\_\_\_ (initial).
